This is a requirements contract. Contract period is for five (5) years from the award date and the not to exceed amount is \$10,000,000.00.

STATEMENT OF WORK

Specifications For Chemical, Biological, and Radiological (CBR) Air Filtration Devices and Systems

1. The CBR Collective Protection System (CPS) Branch (B57) of the Naval Surface Warfare Center, Dahlgren Division (NSWCDD), Dahlgren, VA requires fabrication of filtration devices and systems designed to remove CBR contaminants from a forced air environment. The deliverables of this contract will be fabricated in accord with Government drawings and prepared, as necessary, for "trouble-free" assembly and installation by the Government at shipboard and land-based sites. These devices and systems will support both the CPS Backfit Program and building protection projects.

1.1 Overall Description

The contractor shall fabricate filter housing units, filter housing systems, filter housing systems for compressors, tool kits, pressure control valves, and incorporate accessories per Government-provided design drawings. Filter houses, filter housing systems, and accessories may be customized to accommodate a variety of installation environments. Shipment may be to any designated location within the Continental United States (CONUS).

1.2 Technical Points of Contact

Technical points of contact will be designated in individual delivery orders.

2.0 Referenced Documents

All hardware deliverables are fabricated in accordance with Government-owned drawings. Cited drawings will be furnished, in PDF format, by the Government.

3.0 Standardized requirements

Many drawings used in this procurement call out military standards or specifications. The contractor may use approved equivalent industry standards. Substitution of industry standards, in lieu of military standards or specifications, must be specifically noted whenever the contractor submits a proposal for an engineering change (new drawing, design, specification) or a proposal for a customized deliverable.

4. Deliverables

4.1 CBR Filter Houses

The CBR filter houses of Drawing 6573690-X are the heart of both shipboard and building air filtration systems. The contractor shall fabricate filter houses per the specified drawing. These units may be purchased separately or in groups to be assembled into unified banks, as needed, for a system.

4.1.1 Ship Systems

Ship air filtration systems utilize the CPS System Drawing 6263500-X. These systems incorporate filter houses defined at paragraph 4.1 along with various plates, supports, gaskets, and hardware. Shipboard systems are usually designed in a 2 X 3 configuration (2 houses wide, 3 tall). Ship systems may be specified with composition of either

aluminum (drawing 6263500-14) or steel (drawing 6263500-6). The contractor shall fabricate all components for shipboard systems per the drawings. The contractor shall assemble these systems prior to shipment to ensure proper component fit. The system shall then be marked for reassembly and packaged as necessary per shipping requirements for transport. The assembly shall include all hardware, adhesives, sealants, gaskets and other material necessary to complete the assembly in the field.

4.1.2 Building Systems

Building air filtration systems also utilize the filter houses detailed in paragraph 4.1. The filter houses are incorporated with plenum boxes and other components to make up the building systems. These building systems can incorporate any of the three larger-size CBR filter houses - 6573690-3 (600 CFM), 6573690-4 (800 CFM), and 6573690-5 (1000 CFM). The contractor shall fabricate and assemble building system components per the drawings. The contractor shall assemble these systems in their facility prior to shipment to ensure proper component fit. The system shall then be marked for reassembly, disassembled, and packaged for transport. The system shall include all hardware, adhesives, sealants, gaskets and other material necessary to complete the assembly in the field.

4.1.3 Pressure Control Valve and Tool Kits

The contractor shall fabricate pressure control valves (Drawing 6264251) and tool kits (Drawing 6263472) per the noted drawings.

4.1.4 Filter Systems for Air Compressors

Filter systems for air compressors (Drawing CPSA3-4-1) provide CBR filtration to low- and high-pressure shipboard air compressors. These systems utilize one of the CBR filter houses (Drawing 6573690-X) described at paragraph 4.1. The CBR filter house is incorporated into a frame with a plenum and door.

4.1.5 Customized Filter Houses, Housing Systems, and Accessories

The standard CBR filter houses identified in Paragraph 4.1, and the systems comprised of these units, must often be customized in some way. This customization may include, but is not limited to, moving holes, adding holes, changing the size of holes and adding material to incorporate a fan. Customization may also reduce the components of a standard design. The Government may also require device accessories, such as fan filters, rain hoods, access panels, etc., to be modified to fit a deliverable and to fit an installation site.

4.1.6 Documentation: Assembly Instructions and Digital Photographs

When required by delivery order, the contractor shall provide assembly instructions that supplement NSWCCD drawings for engineering changes or customized equipment. Instructions shall contain step-by-step assembly instructions and, as required, appropriate digital photographs. Any special assembly techniques or potential pitfalls shall be identified in the document. This document is envisioned as a working aid containing 1 to several pages of text and as many as 5 to 10 digital photographs showing system installation steps. Instructions should be relatively simple and it should assume the team performing assembly in the field is technically competent. These instructions shall include digital photographs when specified by delivery order. Stand-alone digital photos may be required.

5.0 Quality Control

5.1 System Test and Acceptance

All systems must be assembled at the contractor's facility to ensure proper fit between components. Alignment and fit of assembled items must be verified in accordance with the appropriate drawings. All CBR filter houses (Drawing 6573690-X, whether procured separately or as a system) must be fit checked with an M98 Gas Particulate Filter Set to ensure proper fit between the filter and the housing. System acceptance testing may include an aerosol leak test conducted, on a non-interference basis, by NSWCCD personnel.

5.2 Quality Assurance

The contractor shall be responsible for ensuring that all components and final design products are constructed per the contract specifications and drawings. The contractor shall have a quality assurance program in place in their

facility to ensure deliverables are of proper form and fit and, ultimately, prevent failure of in-field assembly and installation efforts.

6. Post-award quotations for requirements:

All orders shall be firm fixed priced. The contractor shall state any assumptions made in their price and give an itemized breakdown of the costs of each material item and equipment operation to support the reasonableness of items not fixed priced in the contract.

7. Shipment

The Government will state the proper package size and configuration for shipping at the time of the request for quote from the contractor. Shipping instructions will be part of the delivery order and design package. The contractor shall coordinate shipping requirements with NSWCDD for each order to ensure proper package size and configuration for shipboard handling.

8. Annual Pricing Review for Filter Housings, Pressure Control Valve, and Tool Kit.

The unit pricing in Attachment A have been established based upon offered discounts from the contractor's Commercial Price List or GSA Schedule Prices for filter housings. These unit prices are subject to both upward and downward adjustment. The contractor may submit price decreases any time during the contract period. The contractor may request price increases to be effective on the contract award anniversary date, provided the increases result from a reissue or other modification to the contractor's published commercial or GSA Schedule prices, if applicable, that were used as the basis for the contract award. Requests for price increases must be submitted no later than 60 days prior to the contract anniversary date. In accordance with the contractor's contract level proposal, annual price increases are limited to 5% annually. The price increase will be effective upon incorporation to the contract by formal written modification. This provision applies only to filter housings, pressure control valves, and tool kits. All other items under this contract are fixed priced at the order level based upon job specific drawings.

CLAUSES INCORPORATED BY FULL TEXT

52.212-1 INSTRUCTIONS TO OFFERORS--COMMERCIAL ITEMS (JAN 2004)

(a) North American Industry Classification System (NAICS) code and small business size standard. The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) Submission of offers. Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. Offers may be submitted on the SF 1449, letterhead stationery, or as otherwise specified in the solicitation. As a minimum, offers must show--

- (1) The solicitation number;

The information provided by the offeror will be used in the analysis of future price adjustment requests as provided for in the contract)
 - (7) "Remit to" address, if different than mailing address;
 - (8) A completed copy of the representations and certifications at FAR 52.212-3;
 - (9) Acknowledgment of Solicitation Amendments;
 - (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
 - (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.
- (c) Period for acceptance of offers. The offeror agrees to hold the prices in its offer firm for 30 calendar days from the date specified for receipt of offers, unless another time period is specified in an addendum to the solicitation.

If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.
 - (2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and--
